1. Thulung Dudhakoshi Rural Municipality Mukli, Solukhumbu, invites sealed bids or electronic bids from eligible bidders for the **Construction of Office Building of Thulung Dudhakoshi Rural Municipality in Mukli, Solukhumbu** under National Competitive Bidding procedures for the following work.

Only authorized firm/company that supplies 75 mm sandwich pre-fabricated and 50 mm pre-fabricated panel and does construction works of building using the panel, and that which has proofed experience of such work for at least last two years, are eligible to apply for the bidding process in case of building construction.

2. Only eligible bidders with the following key eligibility criteria should participate in this bidding: [Eligibility criteria as per clause 40 (2) of PPR 2075] Eligible Bidders may obtain further information and inspect the Bidding Documents at the office of **Thulung Dudhakoshi Rural Municipality, Solukhumbu**. Or receive bid documents electronically upon request by fulfilling the process explained in point 4 below.
3. A complete set of Bidding Documents may be purchased from the office of **Thulung Dudhakoshi Rural Municipality Mukli, Solukhumbu** by eligible Bidders on the submission of a written application, along with the copy of company/firm registration certificate, business registration certificate, VAT and PAN registration certificate and tax clearance of fiscal year 2073/074 and upon payment of a non-refundable fee of above mentioned amount till **2075/2/24 (7th June, 2018) 5:00 pm**. If so requested, the Bidding Documents can also be sent by post/courier services upon payment of additional cost of NRs. 2000.00. However, the Employer will not be responsible for delay or non-delivery of the documents so sent. June, 2018)

Bidder who chooses to receive the bid documents electronically may deposit the above mentioned non-refundable fee (Rs. 3000.00) of bid document in the bank account of Thulung Dudhakoshi Rural Municipality as specified below and the scanned copy (PDF format) of the Bank deposit voucher shall be sent to the email: **thulungdudhkoshirm@gmail.com** along with an official application letter requesting electronic bid documents by the bidder. Upon the request, the Employer shall send the bid documents via Email to the bidders. However, the Employer will not be responsible for delay or non-delivery of the documents so sent.

5. Pre-bid meeting shall be held at the office of **Thulung Dudhakoshi Rural Municipality, Mukli, Solukhumbu** at **11.00 am on 2075/02/09 (23rd May, 2018)**.
6. Sealed bids must be submitted to the office of **Thulung Dudhakoshi Rural Municipality** by hand/courier on or before **12:00 pm on 2075/02/25 (8th June, 2018)**. Bids received after this deadline will be rejected.
7. The bids will be opened in the presence of Bidders' representatives who choose to attend at **2:00 pm on 2075/02/25 (8th June, 2018)** at the office of **Thulung Dudhakoshi Rural Municipality, Mukli, Solukhumbu**. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in PDF format along with other document as mentioned in tender document, amounting to a minimum of valid for 120 days beyond the validity period of the bid after dateline for Bid submission last date.
8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
9. Bidders may withdraw or modify its bids by sending a written notice in a sealed envelope, duly signed by an authorized representative, and shall include a copy of the authorization in accordance with ITB 20.2 before 24 hours prior to the deadline of submission of bids.
10. Other provisions will be as per prevailing Public Procurement Act 2063 and Public Procurement Regulation 2064 (Amended).
